### Check in Procedure

Upon arriving at Main Street you will be required to check in at the Wray Chamber booth. Please refer to the map for the location. If you have registered online an original signature will be required on the rules and regulations. You will then be directed to your booth space. Food Vendors will be required to have a copy their health department permits and sales tax licenses. Retail Vendors will be required to have a copy of their required sales tax licenses.

## Rules and Regulations

- Once this form is complete, including a signature and returned, then we will contact you to let you know what spot you have been placed at.
- The Fun Night Festivities are from 6 p.m. to 10 p.m., weather permitting. We do NOT give refunds because of weather.
- Set-up for booths will begin at 5:30 p.m. Do NOT set up before 5:30 p.m. Many businesses on Main Street may still be open and you will disrupt their business; this can result in the loss of your booth privileges, with no refunds.
- Any damages are your responsibility. FOOD VENDORS ATTENTION! No cooking apparatus is allowed on the sidewalks. Proper disposal and clean-up of any oil or grease is your responsibility. If your booth space is not properly cleaned it can result in you not being allowed back to Fun Night for a period of five (5) years.
- Electricity on Main Street is limited! If you need electricity, please let us know before Tuesday July 26th and we'll make every effort to make that available for you. However, we encourage you to make other arrangements in case we are unable to.
- Please remove all vehicles from Main St. after unloading.
- You are not allowed to sell or provide samples of any of the following items: Silly string, any type of spray items or popping fireworks; anything related to alcohol or tobacco, CBD or THC products or anything that makes profane noises or smells such as fart bags or fart bombs. If you are caught selling these items, you will be asked to leave the premises IMMEDIATELY and will not be allowed back to Fun Night for a period of five (5) years.
- The Wray Chamber of Commerce reserves the right to restrict the sale of any item that we deem inappropriate the evening of the event. Failure to cooperate will result in immediate removal from Fun Night and you will not be allowed back to Fun Night for a period of five (5) years.

Food Vendors are limited to the food court area, spots S4-S20. Space is limited for food. Please submit your application asap. For immediate registration or to check availability please register online at [wraychamber.net](http://wraychamber.net).
