Rules & Regulations

- Registration will begin at 11:00 AM at the Mud Volleyball Courts and will close at 11:25 AM and the tournament will begin PROMPTLY at 11:30 AM.
- You are not fully registered until you pay your registration fee!
- A spot is NOT guaranteed if you wait till the day of the tournament to register.
- You MUST check in whether you have pre-registered or not! If you fail to check-in by 11:25, you will forfeit your spot and your registration fee.
- Teams must be comprised of three (3) males and three (3) females in the water. A team beginning the tournament with six, or more, players may play a match with five players, provided that team has a mix of three players of one gender and two of the other. If not, the team will forfeit.
- More than six team members is okay, but you may only have six players in the water at any time. Only teams with a minimum six-person roster will be allowed to register.
- Water is in-bounds; dirt is out of bounds.
- Serves must be from in the water.
- Calls are on your honor.
- Rulings from the tournament coordinators are final.
- Two (2) team losses means elimination.
- You may be a member of two (2) teams, at maximum. But NO player will be allowed to change teams during a match.
- SHOES ARE REQUIRED WHILE IN THE MUD!!!
- No players or spectators young or old allowed in the pit in between games.

**PARENTAL CONSENT RELEASE AND WAIVER OF LIABILITY
AND ASSUMPTION OF RISK AGREEMENT**

FOR GOOD AND VALUABLE CONSIDERATION, including permission for _____ (the "minor") to participate in **Mud Volleyball** and related activities, I, the parent/guardian of the minor for myself and on behalf of the minor:

1. Consent to the minor's participating in the event or activity; and agree that prior to the minor's participation in the event or activity the minor and I will inspect the facilities, equipment, and areas where the event or activity is being conducted and, if either of us believes any of them are unsafe, I will immediately advise the person supervising the event, activity, facility or area;
2. Acknowledge that the minor and I fully understand that the minor's participation may involve risk of serious injury or death, including economic losses, which may result not only from the minor's own actions, in-actions, or negligence, but also from the actions, in-actions, or negligence of others, the condition of the facilities equipment, or areas where the event or activity is being conducted, the rules of play, or this type of event or activity;
3. Release, waive, discharge and relinquish **Wray Chamber of Commerce** and **City of Wray** and their officers, employees, and agents from any liability, loss, damage, claim, demand or cause of action against them attributable to the minor's participation in the event or activity, whether same shall arise by their negligence or otherwise;
